

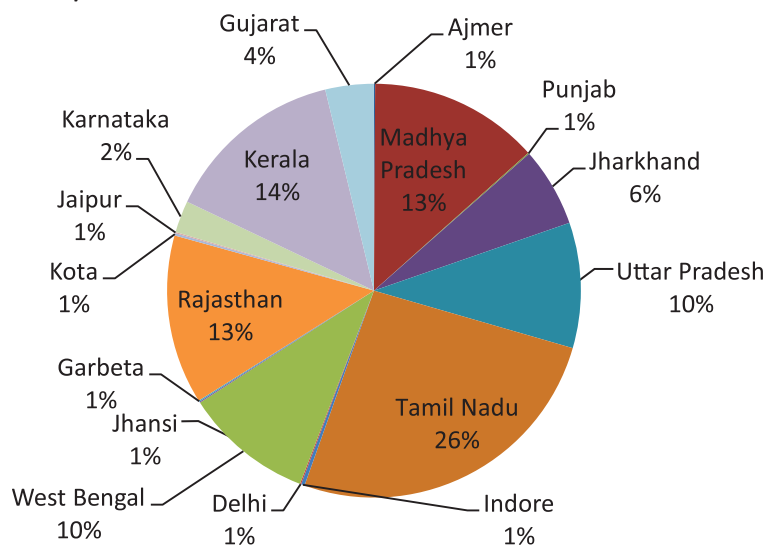


Result of the Opinion Poll of Management and Teaching Staff of Schools on Children's Safety and Well-being as of 10th November 2023

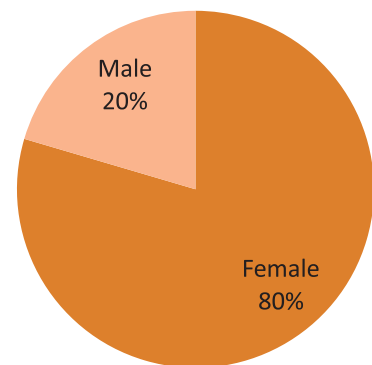

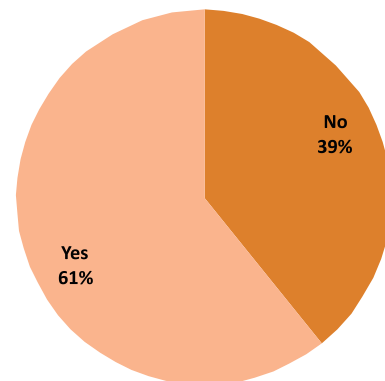
Survey Description

The survey contains 17 close-ended questions. Participants must select any one of the options in the check box for each question. There are no right or wrong answers.

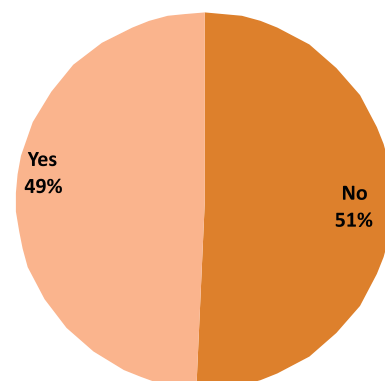

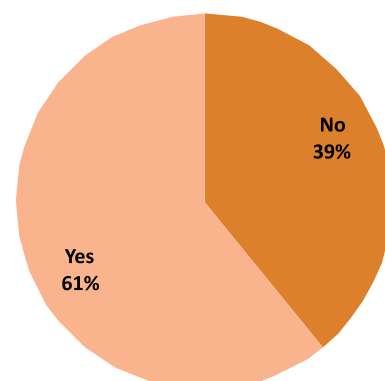

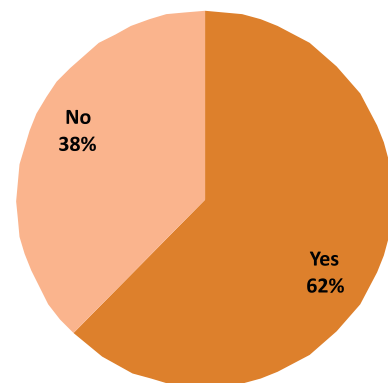
5A. Inculcation of good behaviour in children is primarily a matter of?



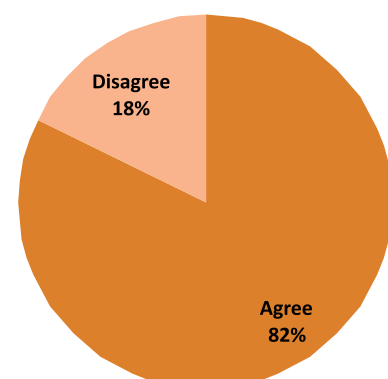

6A. Do you think that the mental capacity of a child to think and act like an adult can be established through any psychological (psychometric) test?

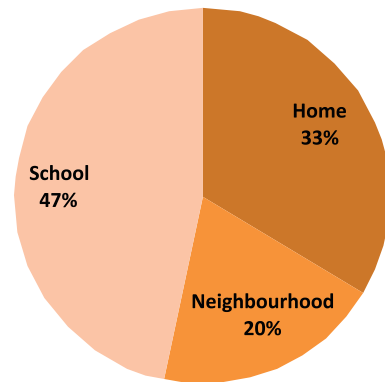

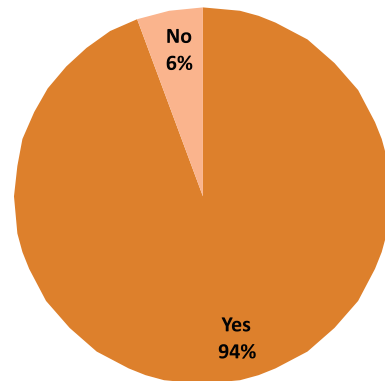




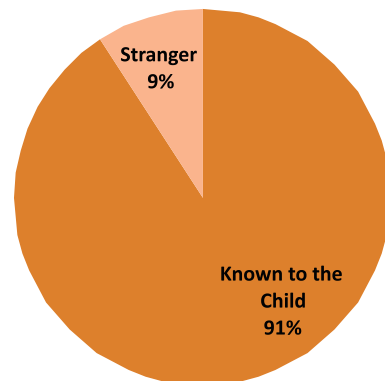
7. Where do you think, in the Indian context, it is easiest to identify and report cases of child sexual abuse?



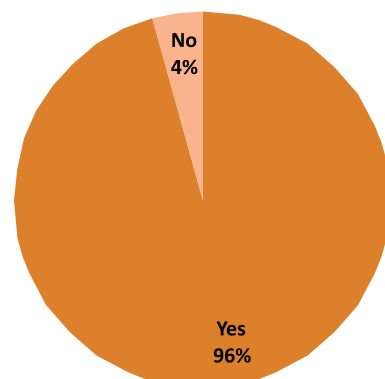
8. What do you think, are mental health issues still stigmatized in the Indian society?

10. Do you think mental health assessments should be a part of children's regular health checkups?

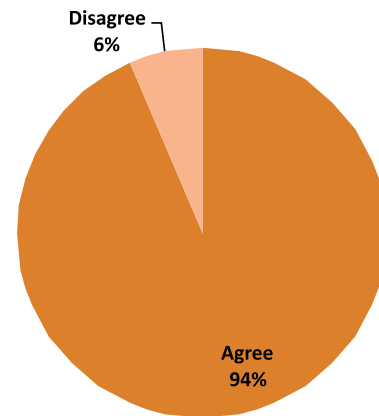

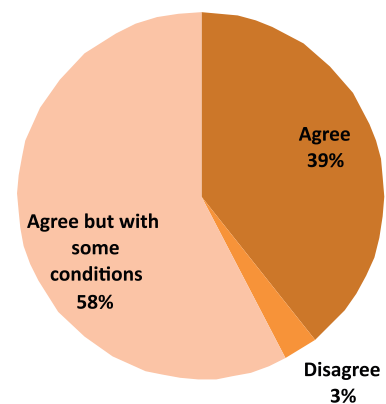

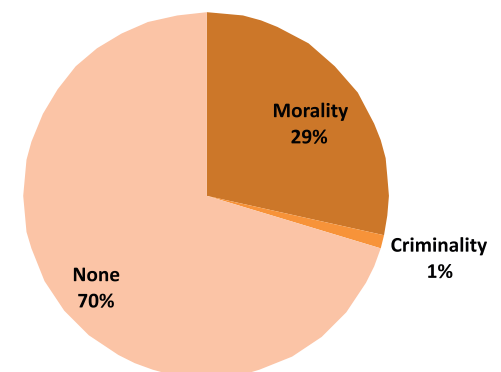
11A. Do you agree that children should be made aware of their rights even with the possibility of misuse?



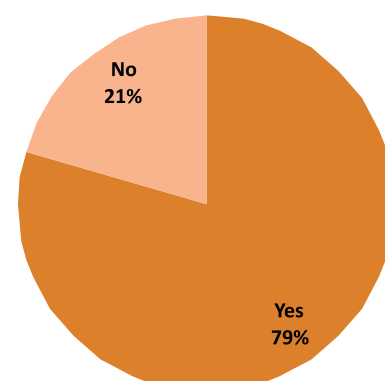

13. In India, parents usually ask a set of why questions even when the child is not at fault. For instance, imagine a child getting hurt while playing outside on a hot summer day; the parents question the child about why did you go out on such a hot day? Why didn't you take my permission? Why didn't you take someone with you? Why did you wear such a dress? So on and so forth, making the child feel guilty. Do you think asking such questions to the child paves the way for the abuser to apply a similar strategy to shift the blame onto the child and to take advantage of the child?
