We request that you provide us with the list of the principals along with their name, designation, contact number, WhatsApp, email etc, from your jurisdictional area on or before




August 20, 2023. Their presence and engagement in this programme will help to promote a safer environment for our children and ensure that these essential laws are well understood and implemented.
