4. Introduction of "Project CACA - A safety programme for schools to keep our students Happy, Healthy and Safe" in accordance with the Gazette notification of POCSO Rules 2020.
5. Introduction of DLSAs and various services provided by them.

Schools across India have partnered with Project CACA. It is the flagship school safety programme by NGO Social Axiom Foundation, Delhi. As a comprehensive, curriculum-integrated intervention, it addresses the legal, psychological, and academic aspects of children's safety and is implemented by schools as part of their Child Protection and Wellbeing Policy. It constitutes the preventive mechanisms within the child protection framework and supports schools in complying with various mandates on child protection and safety.


