1. Raise legal awareness as well as sensitize the Principals and Head of Schools of Tiruvallur district on the POCSO Act 2012, and JJ Act.
2. Raise legal awareness as well as sensitize about different kinds of abuses that children face and their prevention.
3. Help schools formulate a child safety and well-being committee and implement policies to ensure an enabling and empowering environment for the children.
4. Introduction of "Project CACA – A safety programme for schools to keep our students Happy, Healthy and Safe" to all the Principals and Heads of the schools to build consensus on its implementation under the school safety policy in accordance with the Gazette notification of POCSO Rules 2020.
5. Introduction of DLSAs and various services provided by us.

The purpose of the programme is to sensitize , raise awarness about the crucial issue of the child protection and well-being, further this would help to promote a safer environment for the children and ensure that these essential laws are well understood and implemented. Furthermore, their active participation will significantly contribute to the dissemination of vital information on children's wellbeing and safety, the Protection of Children from Sexual Offences (POCSO) Act, and the Juvenile Justice Act.
