A need of the hour, Project CACA is an academic safety programme that aligns with the objectives of the Gazette Notification POCSO Rules 2020 and various other government guidelines.

It is with great pleasure that I bring to your kind attention to an upcoming event of significant importance that the District Legal Services Authority Saharanpur is organizing in collaboration with NGO Social Axiom Foundation - Project CACA (Children Against Child Abuse).

A two-hour online webinar on "Child safety & Well-being and Consensus Building on Project CACA" covering Legal POCSO Act, Juvenile Justice Act, & Legal Services. It is scheduled to take

place via the online platform Zoom on Friday, September 22nd 2023, from 10:00 am to 12:00 pm.

As a capacity-building webinar, it will help principals put together a policy framework to further define the roles and responsibilities of the stakeholders at the grassroots level. The objectives of the webinar:

1. Raise legal awareness as well as sensitize the Principals and Head of Schools of Saharanpur district on the POCSO Act, 2012, and JJ Act.
2. Raise legal awareness as well as sensitize about different kinds of abuses that children face and their prevention.
3. Help schools formulate a child safety and well-being committee and implement policies to ensure an enabling and empowering environment for the children.
4. Introduction of "Project CACA – A safety programme for schools to keep our students Happy, Healthy and Safe" to all the principals and heads of the schools to build consensus on its implementation under the school safety policy in accordance with the Gazette notification of POCSO Rules 2020.
5. Introduction of DLSAs and various services provided by them.

In the light of this, I request you to issue necessary instructions to the Principals and the Heads of the Schools in Saharanpur District to participate in the aforesaid online webinar. We solicit the support in form of:

- a) A formal invitation letter from your office issued to the principals and the heads of the schools in Saharanpur District soliciting their mandatory attendance.
- b) Providing a list of Principals, Directors, Headmasters, and Heads of Schools ICSE, CBSE, State Board affiliated schools of all types Self-financed, Government and Grant Aid in Saharanpur District along with their Names, Designation, Contact number, Email address, etc. from your jurisdictional area on or before 15th September, 2023.

We believe their presence and engagement in this programme will help promote a safer environment for our children and ensure that these essential laws are well understood and implemented. Furthermore, their active participation will significantly contribute to the dissemination of vital information on Children's Wellbeing and Safety, the Protection of Children from Sexual Offences (POCSO) Act, and the Juvenile Justice Act.

Project CACA has been actively reaching out to schools in Uttar Pradesh and has implemented the project as a pertinent step towards creating a safer environment for children - focused on empowering students, teachers, parents, and support staff and building capacity of the schools to address the critical issue of child safety and well-being effectively.
